The Import Duties (Bailiwick of Guernsey) (No. 56) Order, 1968

THE BOARD OF ADMINISTRATION, in pursuance of the powers conferred upon it by the Import Duties (Bailiwick of Guernsey) Laws, 1932 to 1960, hereby orders:-

1. In the Second Schedule to the Import Duties (Bailiwick of Guernsey) (No. 55) Order, 1968 (a), there shall be made in the headings specified in the first column of the Schedule to this Order the amendments set out in the second column of that Schedule.
2. The Interpretation (Guernsey) Law, 1948, shall apply to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.
3. (1) This Order may be cited as the Import Duties (Bailiwick of Guernsey) (No. 56) Order, 1968.  
(2) Subject to the provisions of sub-section (c) and sub-section (d) of section two of the Import Duties Act (Bailiwick of Guernsey), 1932, as amended, this Order shall come into force on the first day of January, nineteen hundred and sixty-nine.
