

**The Social Insurance (Contributions) (Amendment)  
Regulations, 2012**

**THE SOCIAL SECURITY DEPARTMENT**, in exercise of the powers conferred upon it by sections 3, 6, 8, 11, 15, 16A and 116 of the Social Insurance (Guernsey) Law, 1978, as amended<sup>a</sup>, and of all other powers enabling it in that behalf, hereby orders:-

**Amendment.**

1. Immediately after paragraph (4) of regulation 15 of the Social Insurance (Contributions) Regulations, 2000, as amended<sup>b</sup> insert the following paragraph -

"(5) An employer who, or on whose behalf another person duly authorised by that employer, declares or warrants in such electronic or other format approved by the Department, that the information contained within

**Interpretation.**


2. The Interpretation (Guernsey) Law, 1948<sup>c</sup> applies to the interpretation of these Regulations as it applies to the interpretation of a Guernsey enactment.

**Citation, commencement and extent.**

3. (1) These Regulations may be cited as the Social Insurance (Contributions) (Amendment) Regulations, 2012 and shall come into force on the 1<sup>st</sup> day of October 2012.

(2) These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

## EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport)

'These Regulations amend the Social Insurance (Contributions) Regulations, 2000 to allow completed social insurance contribution schedules returned by employers in electronic form to be accompanied by a declaration similarly in electronic form instead of the current requirement of a paper document.

These Regulations came into operation on 1 October 2012.
