**The Import (Control) (Alderney) (Amendment No 2)
Order, 2012**

Made 29th May 2012

Coming into operation 1st June 2012

The States of Alderney Policy and Finance Committee, in pursuance of the powers conferred upon it by Article 1 of the Import and Export (Control) (Alderney) Law, 1946^a **HEREBY ORDERS:-**

Amendments to Order of 2010.

1. The Import (Control) (Alderney) Order, 2010^b is amended as follows.
2. Schedule 7 to that Order is revoked.
3. Schedule 8 to that Order is amended by inserting, immediately after paragraph 16, the following paragraph –

"17. (a) 2-(ethylamino)-2-(3-methoxyphenyl)cyclohexanone,

- (b) any stereoisomeric form of 2-(ethylamino)-2-(3-methoxyphenyl)cyclohexanone,
- (c) any salt of a substance specified in subparagraph (a) or (b), or
- (d) any preparation or other product containing a substance specified in any of subparagraphs (a) to (c)."

Interpretation.

4. (1) In this Order, a reference to any enactment is a reference to the enactment as from time to time amended, varied, re-enacted (with or without modification), extended or applied.

(2) The provisions of the Interpretation (Guernsey) Law, 1948^c apply to the interpretation of this Order throughout the Island of Alderney as they apply to the interpretation of an enactment in force in the Island of Guernsey.

Citation and commencement.

5. This Order may be cited as the Import (Control) (Alderney) (Amendment No. 2) Order, 2010, and comes into force on the 1st June, 2012.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order adds 2-(ethylamino)-2-(3-methoxyphenyl)cyclohexanone and related substances, commonly known as methoxetamine, to the list of prohibited imports in Schedule 8 to the Import (Control) (Alderney) Order, 2010.

It also revokes Schedule 7 to that Order as the substances listed in that schedule are now listed as Class B controlled drugs in the Misuse of Drugs (Bailiwick of Guernsey) Law, 1974.

This Order comes into force on the 1st June, 2012.
