THE BOVINE SEMEN (EXPORTATION) (GREAT BRITAIN) ORDER, 1967

The States Committee for Agriculture, under and by virtue of the powers conferred upon it by subsection (1) of section three A of the Bovine Semen and Artificial Insemination Ordinance, 1957, as amended (a), and of all other powers enabling it in that behalf, hereby orders:-

Export of
semen to
Great Britain

1. The exportation from the Island of a consignment of bovine semen to Great Britain is hereby permitted if:-

- (a) the consignment consists wholly of semen obtained from bulls registered in the Herd Book of the Royal Guernsey Agricultural and Horticultural Society (hereinafter referred to as "the Society") and qualified by the Society for public service;
- (b) the consignment consists wholly of semen collected and prepared and dispatched from the place of preparation under the control and supervision of a person approved in that behalf by the States Committee for Agriculture (hereinafter referred to as "the Committee");
- (c) the consignment is accompanied by a certificate in the form and containing the particulars set out in the Schedule to this Order.

Copies

2. One copy of the certificate as aforesaid shall be delivered by the exporter of the semen concerned to the Committee and another copy of such certificate to the Society.

Inter-
pretation

3. The Interpretation (Guernsey) Law, 1948(b) shall apply to the interpretation of this Order as it applies to the interpretation of an enactment.

Citation

4. This Order may be cited as the Bovine Semen (Exportation) (Great Britain) Order, 1967.

5. This Order shall come into force on the first day of November, nineteen hundred and sixty-seven.
