The Parking Places (Amendment) Order, 1966.

Made the 13th April, 1966.

Coming into operation on the 20th April, 1966.

THE ISLAND POLICE COMMITTEE, in pursuance of the powers vested in it by section one of the Road Traffic (Parking Places) Ordinance, 1963(a), and of all other powers enabling it in that behalf, hereby orders:-

1. The Parking Places Order, 1964, as amended(b) is hereby further amended as follows, that is to say:-

- (a) in section six thereof the word, letter and figures "or No. A39" are hereby repealed and a comma and the word, letters and figures "No. A39, No. A40, No. A41 or No. A42" are hereby substituted therefor;
- (b) in subsection (3) of section seven thereof the word, letter and figures "or No. A39" are hereby repealed and a comma and the word, letters and figures "No. A39, No. A40, No. A41 or No. A42" are hereby substituted therefor;
- (c) in paragraph (b) of section eight thereof the word, letter and figures "and D48" are hereby repealed and a comma and the word, letters and figures "D48, D49 and D50" are hereby substituted therefor;
- (d) in paragraph (d) of section eight thereof the letter and figures "D44" are hereby repealed;
- (e) at the end of the entry relating to disc parking place No. D10 in the third column of Part I of the Schedule thereto there are hereby inserted the words "and approved parking place No. A42";
- (f) the whole of the entry relating to disc parking place No. D13 in the third column of Part I of the Schedule thereto is hereby repealed and the following entry is hereby substituted therefor -

"The Albert Pier between a line joining a parking sign placed on the north side of the Pier as near as may be to the eastern end of the States Annexe to a parking sign placed opposite thereto on the south side of the Pier and a line joining two parking signs one placed on the north side of the Pier and the other placed opposite thereto on the south side of the Pier to the east of the Albert Statue but excluding approved parking place No. A39.";

- (g) the whole of the entry relating to disc parking place No. D15 in the third column of Part I of the Schedule thereto is hereby repealed and the following entry is hereby substituted therefor -

"The west side of the road between a parking sign placed as near as may be to the entrance to the Bonded Stores and a parking sign placed as near as may be to the bottom of Rectory House steps.";

- (h) the entries relating to disc parking place No. D44 in each of the columns of Part I of the Schedule thereto are hereby repealed;
- (i) immediately after the entries relating to disc parking place No. D48 in each of the columns of Part I of the Schedule thereto there are hereby inserted respectively the entries in each of the columns of Part I of the Schedule to this Order;
- (j) the whole of the entry relating to approved parking place No. A39 in the third column of Part II of the Schedule thereto is hereby repealed and the following entry is hereby substituted therefor -

"The portion of the centre of the Pier to the east of the Albert Statue indicated by parking signs as being reserved for public vehicles standing or plying for hire";

- (k) immediately after the entries relating to approved parking place No. A39 in each of the columns of Part II of the Schedule thereto there are hereby inserted respectively the entries in each of the columns of Part II of the Schedule to this Order.

2. (1) This Order may be cited as the Parking Places (Amendment) Order, 1966.

(2) This Order and the Parking Places Orders, 1964 and 1965, may be cited together as the Parking Places Orders, 1964 to 1966.

3. This Order shall come into force on the twentieth day of April nineteen hundred and sixty-six.

SCHEDULE

"D49	Mansell Street, Saint Peter Port.	The south west side of the road between parking signs placed as near as may be to each end of Holy Trinity Church.
D50	Mansell Court, Saint Peter Port.	The east side of the road between parking signs placed thereon."

PART II

"A40	Bonded Stores, Saint Peter Port.	The portion of the west side of the road indicated by parking signs as being reserved for public vehicles standing or plying for hire.
A41	The Market	The portion of the road at the south west end of the Market indicated by parking signs as being reserved for public vehicles standing or plying for hire.
A42	Victoria Pier, Saint Peter Port.	The portion of the north side of the Pier indicated by parking signs as being reserved for public vehicles standing or plying for hire.
A43	Grandes Rocques, Castel.	The portions of both sides of the road along the south west boundary of Grandes Rocques Hotel between parking signs placed on both sides of the road."
