

The Parking Places (Amendment) Order, 1965.

Made the 28th April, 1965.

Coming into Operation on the 3rd May, 1965.

THE ISLAND POLICE COMMITTEE, in pursuance of the powers vested in it by section one of the Road Traffic (Parking Places) Ordinance, 1963, and of all other powers enabling it in that behalf, hereby orders:-

1. The Parking Places Order, 1964, as amended(a), is hereby further amended as follows, that is to say:-

- (a) in paragraph (b) of section eight thereof the word, letter and figures "and D16" are hereby repealed and a comma and the word, letters and figures "D16 and D48" are hereby substituted therefor;
- (b) in paragraph (d) of section eight thereof the word, letter and figures "and D46" are hereby repealed and a comma and the word, letters and figures "D46 and D47" are hereby substituted therefor;
- (c) in paragraph (e) of section eight thereof the letters, figures and commas "D3, D4, D9, D12, D17, D30" are hereby repealed;
- (d) in section eight thereof the full stop is hereby deleted and a semi-colon is hereby substituted therefor and immediately thereafter there is hereby inserted the following additional paragraph lettered "(g)" -
"(g) in disc parking places Nos. D3, D4, D9, D12, D17 and D30 -
 - (i) between the hours of eight o'clock in the forenoon and six o'clock in the afternoon of any day for a continuous period greater than a period of five hours, or

(ii) between the hours of six o'clock in the afternoon of any day and eight o'clock in the forenoon of the day next following for a continuous period greater than a period of ten hours.";

- (e) immediately after the entries relating to disc parking place No. D46 in each of the columns of Part I of the Schedule thereto there are hereby inserted respectively the entries in each of the columns of Part I of the Schedule to this Order;
- (f) in the entries relating to disc parking places Nos. D12 and D13 in the right hand column of Part I of the Schedule thereto the word "western" where it occurs in those entries is hereby repealed and the word "eastern" is hereby substituted therefor;
- (g) the entries relating to approved parking place No. MB9 in each of the columns of Part III of the Schedule thereto are hereby repealed and there are hereby inserted respectively therefor the entries in each of the columns of Part II of the Schedule to this Order.

2. This Order may be cited as the Parking Places (Amendment) Order, 1965, ~~and this Order, the Parking Places (Amendment) Order, 1964, and the Parking Places Order, 1964,~~ may be cited together as the Parking Places Orders, ~~1964 and 1965.~~

3. This Order shall come into force on the third day of May, nineteen hundred and sixty-five.

SCHEDULE

Part I

"D47	Bordage, Saint Peter Port	The front portion of the off street parking area at the south-western end of the road within the limits indicated by parking signs.
D48	Pedvin Street, Saint Peter Port	The portion of the lower end of the road within the limits indicated by parking signs."

Part II

"MB9	Bordage, Saint Peter Port	The rear portion of the off street parking area at the south-western end of the road within the limits indicated by parking signs as being reserved for motor bicycles."
