THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by sections seventy-two and seventy-seven of the Social Insurance (Guernsey) Law, 1964, as amended, and of all other powers enabling it in that behalf, hereby orders:-

Amendment of regulation one of the principal regulations.

1. In regulation one of the Social Insurance (Pensions, Existing Beneficiaries and Other Persons) (Transitional) (Guernsey) Regulations, 1971 (hereinafter referred to as "the principal regulations") the definition of the expression "the relevant day" is hereby repealed and the following definition is hereby substituted therefor -

"relevant day" means the fifth day of November,
nineteen hundred and seventy-three".

Amendment of regulation five of the principal regulations.

2. Regulation five of the principal regulations is hereby amended as follows, that is to say -

(a) in sub-paragraph (a) of paragraph (1) thereof, the words "two pounds" are hereby repealed and the words "three pounds" are hereby substituted therefor;

(b) in paragraph (4) thereof, the words "five pounds" are hereby repealed and the words "seven pounds" are hereby substituted therefor.

Amendment of regulation six of the principal regulations.

3. Regulation six of the principal regulations is hereby amended

as follows, that is to say -

- (a) the words "five pounds", wherever they occur, are hereby repealed and the words "seven pounds" are hereby substituted therefor;
- (b) the words "one pound and sixty-five new pence", wherever they occur, are hereby repealed and the words "two pounds and thirty new pence" are hereby substituted therefor;
- (c) the words "two pounds", wherever they occur, are hereby repealed and the words "three pounds" are hereby substituted therefor.

Amendment of regulation eight of the principal regulations.

4. Regulation eight of the principal regulations is hereby amended as follows, that is to say -

- (a) the words "five pounds", wherever they occur, are hereby repealed and the words "seven pounds" are hereby substituted therefor;
- (b) in paragraph (5) thereof, the words and figure "paragraph 2 of the Third Schedule" are hereby repealed and the words and figure "paragraph 4 of the Third Schedule" are hereby substituted therefor.

Amendment of regulation nine of the principal regulations.

5. Regulation nine of the principal regulations is hereby amended as follows, that is to say -

- (a) the words "two pounds", wherever they occur, are hereby repealed and the words "three pounds" are hereby substituted therefor;
- (b) in paragraph (3) thereof, the words "three pounds" are hereby repealed and the words "four pounds and twenty new pence" are hereby substituted therefor;
- (c) in paragraph (9) thereof, the words "one pound and sixty-five new pence" are hereby repealed and the words "two pounds and

and thirty new pence" are hereby substituted therefor.

Amendment of regulation ten of the principal regulations.

6. Regulation ten of the principal regulations is hereby amended as follows, that is to say -

- (a) the words "two pounds", wherever they occur, are hereby repealed and the words "three pounds" are hereby substituted therefor;
- (b) in paragraph (3) thereof, for the reference therein to paragraph (2) thereof there is hereby substituted a reference to paragraph (1) thereof;
- (c) in paragraph (5), the words "three pounds" are hereby repealed and the words "four pounds and twenty new pence" are hereby substituted therefor;
- (d) in paragraph (11) thereof, the words "one pound and sixty-five pence" are hereby repealed and the words "two pounds and thirty new pence" are hereby substituted therefor.

Amendment of regulation fourteen of the principal regulations.

7. In regulation fourteen of the principal regulations -

- (a) the words and commas ", as from the appointed day," are hereby repealed;
- (b) the words "two pounds one shilling" are hereby repealed and the words "three pounds and fifty-five new pence" are hereby substituted therefor.

Replacement of Schedules to the principal regulations.

8. The First, Second, Third, Fourth and Fifth Schedules to the principal regulations are hereby repealed and the Schedules set out in the Schedule to these regulations are hereby substituted therefor.


Citation and commencement.

9.(1) These regulations may be cited as the Social Insurance (Pensions,

Existing Beneficiaries and Other Persons) (Transitional) (Amendment) (Guernsey) Regulations, 1973, and these regulations and the principal regulations may be cited together as the Social Insurance (Pensions, Existing Beneficiaries and Other Persons) (Transitional) (Guernsey) Regulations, 1971 and 1973.

(2) These regulations shall come into operation on the fifth day of November, nineteen hundred and seventy-three.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport).

These Regulations amend the Social Insurance (Pensions, Existing Beneficiaries and Other Persons) (Transitional) (Guernsey) Regulations, 1971, so as to provide for the increase of benefit payable to existing beneficiaries in consequence of the higher standard rates of benefit approved by the States on the 27th June, 1973. The increased rates of benefit are restricted to persons who are ordinarily resident in Guernsey.
