The Milk Prices (Guernsey) Order, 1959.

THE STATES DAIRY COMMITTEE, in pursuance of subsection (1) and subsection (3) of section six and subsection (1) of section eight of the Milk (Control) (Guernsey) Ordinance, 1958, and of all other powers thereunto enabling it, hereby orders:-

1. During the twelve months commencing on the first day of May, nineteen hundred and fifty-nine (hereafter in this Order referred to as "the prescribed period") the standard price payable by the Committee in respect of Grade 1 milk delivered to the Committee under the provisions of the Milk (Control) (Guernsey) Ordinance, 1958 (hereafter in this Order referred to as "the Ordinance"), during the prescribed period which is not surplus to the Island's milk requirements shall be two shillings, six pence and one half penny.

2. During the prescribed period the price per pot payable by the Committee in respect of milk delivered to the Committee under the provisions of the Ordinance during the prescribed period and classified as -

- (a) Grade 1 milk -
  - (i) where such milk is not surplus to the Island's milk requirements, shall be, during each period specified in the first column of the Schedule to this Order, the price specified in relation to such period in the second column of that Schedule;
  - (ii) where such milk is surplus to the Island's milk requirements, shall be such reasonable commercial price as the Committee shall from time to time determine;
- (b) Grade 2 milk, shall be one shilling.

3. During the prescribed period the price to be charged for milk on a sale by retail shall be at the rate of nine pence and one half penny per pint:

PROVIDED that the provisions of this section shall not apply to any milk supplied to a beneficiary under any scheme for the time being in force provided by the States for the supply of milk whether free of cost or at a reduced price.

4. The Milk Prices (Guernsey) Order, 1958, is hereby revoked.

5. The Interpretation (Guernsey) Law, 1948, shall apply to the interpretation of this Order as it applies to the interpretation of an enactment.

6. This Order may be cited as the Milk Prices (Guernsey) Order, 1959, and shall come into force on the first day of May, nineteen hundred and fifty-nine.

The sixth day of March, nineteen hundred and sixty, to the twenty-sixth day of March, nineteen hundred and sixty, both dates inclusive.	Two shillings, five pence and one half penny.
The twenty-seventh day of March, nineteen hundred and sixty, to the thirtieth day of April, nineteen hundred and sixty, both dates inclusive.	Two shillings, two pence and one half penny.
