THE IMPORT AND EXPORT OF GOODS (CONTROL)(GUERNSEY) ORDER, 1955.

AMENDMENT TO OPEN GENERAL IMPORT LICENCE

WHEREAS by the Import and Export of Goods (Control)(Guernsey) Order, 1955, dated the 14th June, 1955, (a), the importation into Guernsey of goods consigned from a place outside the United Kingdom, the Island of Jersey, the other Islands of the Bailiwick of Guernsey or the Isle of Man is prohibited unless under the authority of a licence granted by or on behalf of the Board of Administration.

Now, therefore, the Board of Administration, in exercise of its powers under Article 2. of the abovementioned Order, hereby authorises as follows:-

1. The Open General Import Licence dated the 23rd August, 1955, shall be amended in accordance with the Appendix hereto.
2. This amendment shall take effect on the 12th day of October, 1956, and may be modified or revoked at any time by the Board of Administration.

Albania, Argentina, Bolivia, Bulgaria, Canada, Colombia, Costa Rica, Cuba, Czechoslovakia, Dominican Republic, Ecuador, El Salvador, Germany (Russian Zone), Guatemala, Haiti, Republic of Honduras, Hungary, Japan, Korea, Liberia, Mexico, Nicaragua, Panama, Philippines, Poland, Roumania, United States of America, Union of Soviet Socialist Republics, Venezuela

and not consigned from any of these specified countries."
