THE GENERAL FOOD (MAXIMUM RETAIL PRICES) (BAILLIWICK OF GUERNSEY)  
(AMENDMENT NO. 8) ORDER, 1953.

Made ... .. 17th December, 1953.

Coming into Operation ... 27th December, 1953.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The General Food (Maximum Retail Prices) (Bailiwick of Guernsey) Order, 1953 (a) as amended (b) shall be further amended by substituting for Part V - Canned Fish of the Schedule thereto, the Schedule to this Order.
2. The Interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.
3. This Order may be cited as the General Food (Maximum Retail Prices) (Bailiwick of Guernsey) (Amendment No. 8) Order, 1953, and shall come into operation on the 27th day of December, 1953.
