THE FATS AND CHEESE (RATIONING) (BAILLIWICK OF GUERNSEY)  
(AMENDMENT NO. 7) ORDER, 1954.

Made ... .. 19th January, 1954.  
Coming into Operation ... .. 24th January, 1954.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Fats and Cheese (Rationing) (Bailiwick of Guernsey) Order, 1953 (a) as amended (b), shall be further amended as follows:-
  - (a) by inserting in Part 1 thereof, immediately after Article 4, the following Article:-
 

"4A. Notwithstanding anything contained in this Order or in the Principal Order, where a surplus of margarine, cooking fats or cheese is held by a retailer, from quantities he is authorised by permit C.P.2 or Misc. 2 to obtain for supply to his registered customers or to establishments as the case may be, after having supplied the lawful requirements of those customers and establishments the retailer may supply any such surplus margarine, cooking fats or cheese to any person ration free, and any person may obtain any such margarine, cooking fats or cheese from the retailer ration free";
  - (b) by deleting from the Order paragraph (3) of Article 7 thereof.
2. The Interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.
3. The Fats and Cheese (Rationing) (Bailiwick of Guernsey) (Amendment No. 6) Order, 1953 (c), is hereby revoked but without prejudice to any proceedings in respect of any contravention of the Fats and Cheese (Rationing) (Bailiwick of Guernsey) Order, 1953, as amended thereby.
4. This Order may be cited as the Fats and Cheese (Rationing) (Bailiwick of Guernsey) (Amendment No. 7) Order, 1954, and shall come into operation on the 24th day of January, 1954.
