

THE FOOD RATIONING (BAILLIICK OF GUERNSEY) (REVOCATION)  
ORDER, 1954.

SPENT

Made ... .. 1st July, 1954.

Coming into Operation ... 4th July, 1954.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The following Orders and General Licences are hereby revoked but without prejudice to any proceedings in respect of any contravention thereof:-

- (1) The Food Rationing (General Provisions) (Bailiwick of Guernsey) Order, 1953 (a).
- (2) The Food Rationing (General Provisions) (Bailiwick of Guernsey) (Amendment) Order, 1953 (b).
- (3) The General Licence dated 21st January, 1954 (c).
- (4) The General Licence dated 21st January, 1954 (d).
- (5) The Food Rationing (General Provisions) (Bailiwick of Guernsey) (Amendment No. 2) Order, 1954 (e).
- (6) The Meat (Rationing) (Bailiwick of Guernsey) Order, 1954 (f).
- (7) The Bacon (Rationing) (Bailiwick of Guernsey) Order, 1954 (g).
- (8) The Food Rationing (General Provisions) (Bailiwick of Guernsey) (Amendment No. 3) Order, 1954 (h).

2. The Interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.

3. This Order may be cited as the Food Rationing (Bailiwick of Guernsey) (Revocation) Order, 1954, and shall come into operation on the 4th day of July, 1954.
