Revocation Order

THE FOOD (LICENSING OF WHOLESALERS) (BAILLIWICK OF GUERNSEY) (REVOCATION) ORDER, 1954.

Made 10th July, 1954.

Coming into Operation ... 12th July, 1954.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The following Orders are hereby revoked but without prejudice to any proceedings in respect of any contravention thereof:-
 - (1) The Food (Licensing of Wholesalers) (Bailiwick of Guernsey) Order, 1950 (a).
 - (2) The Food (Licensing of Wholesalers) (Bailiwick of Guernsey) (Amendment) Order, 1950 (b).
 - (3) The Food (Licensing of Wholesalers) (Bailiwick of Guernsey) (Amendment No. 2) Order, 1950 (c).
 - (4) The Food (Licensing of Wholesalers) (Bailiwick of Guernsey) (Amendment No. 3) Order, 1950 (d).
 - (5) The Food (Licensing of Wholesalers) (Bailiwick of Guernsey) (Amendment No. 4) Order, 1950 (e).
 - (6) The Food (Licensing of Wholesalers) (Bailiwick of Guernsey) (Amendment No. 5) Order, 1952 (f).
 - (7) The Food (Licensing of Wholesalers) (Bailiwick of Guernsey) (Amendment No. 6) Order, 1953 (g).
2. The Interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.
3. This Order may be cited as the Food (Licensing of Wholesalers) (Bailiwick of Guernsey) (Revocation) Order, 1954, and shall come into operation on the 12th day of July, 1954.
