THE FATS AND CHEESE (RATIONING) (BAILLIWICK OF GUERNSEY) (AMENDMENT) ORDER, 1953.

Made 3rd June, 1953.

Coming into Operation. 14th June, 1953.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Fats and Cheese (Rationing) (Bailiwick of Guernsey) Order, 1953 (a) shall be amended by adding at the end of Article 4 thereof the following:-

"Provided that -

- (a) the maximum quantity of margarine which may be obtained or supplied against each appropriate coupon for margarine in a General Ration Book R.B.1, a Child's Ration Book R.B.2 or a Form R.B.12 valid for use at any time during ration period No. 1 shall be 5 oz.;
- (b) the maximum quantity of cheese which may be obtained or supplied against each appropriate coupon for cheese in a General Ration Book R.B.1, a Child's Ration Book R.B.2 or a Form R.B.12 valid for use at any time during ration period No. 1 or No. 2 shall be 2 oz. except in the case of a Form R.B.12 endorsed by the Issuing Officer with the letters "S" or "SS" when the ration shall remain at 12 oz. and 24 oz. respectively;
- (c) the maximum quantity of butter which may be obtained or supplied against each appropriate coupon for butter in a General Ration Book R.B.1, a Child's Ration Book R.B.2 or a Form R.B.12 valid for use at any time during ration period No. 2, No. 3 or No. 4 shall be 4 oz. (margarine may be obtained in lieu of the whole or part of the butter ration)".

2. The Interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.

3. This Order may be cited as the Fats and Cheese (Rationing) (Bailiwick of Guernsey) (Amendment) Order, 1953, and shall come into operation on the 14th day of June, 1953.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order amends Article 4 of the Fats and Cheese (Rationing) (Bailiwick of Guernsey) Order, 1953, and increases during ration periods Nos. 2, 3 and 4 (14th June, 1953 to 5th September, 1953, inclusive) the butter ration obtainable against each appropriate coupon in a General Ration Book R.B.1, a Child's Ration Book R.B.2 and Temporary Ration Card R.B.12 from 3 oz. to 4 oz.
