THE FATS AND CHEESE (RATIONING) (BAILLIWICK OF GUERNSEY)  
(AMENDMENT NO. 5) ORDER, 1953.

Made ... .. 23rd November, 1953.

Coming into Operation ... 29th November, 1953.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Fats and Cheese (Rationing) (Bailiwick of Guernsey) Order, 1953 (a) as amended (b) shall be further amended by substituting for the entries relating to cheese in the table in the Schedule to the Order, which specifies the amount of the ration, the entries set out in the Schedule to this Order.
2. The Interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.
3. This Order may be cited as the Fats and Cheese (Rationing) (Bailiwick of Guernsey) (Amendment No. 5) Order, 1953, and shall come into operation on the 29th day of November, 1953.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport).

This amending Order, which comes into force on the 29th November, 1953, increases the amount of cheese obtainable against appropriate coupons in -

- (a) a General Ration Book R.B.1, a Child's Ration Book R.B.2 and a Temporary Ration Card R.B.12 from 2 oz. to 3 oz;
- (b) a Leave or Duty Ration Card R.B.8A from 1 oz. to 1½ oz.
