**The Social Insurance (Benefits) (Amendment) Regulations, 2013**

*Made* 8<sup>th</sup> January, 2013  
*Coming into operation* 8<sup>th</sup> January, 2013  
*Laid before the States* , 2013

**THE SOCIAL SECURITY DEPARTMENT**, in exercise of the powers conferred upon it by sections 15, 36, 39 and 116 of the Social Insurance (Guernsey) Law, 1978, as amended<sup>a</sup>, and of all other powers enabling it in that behalf, hereby orders:-

**Revocation.**

1. (1) Regulation 3 of the Social Insurance (Benefits) (Amendment No. 2) Regulations, 2012<sup>b</sup> is revoked and shall be deemed never to have had effect.
- (2) The Social Insurance (Benefits) (Amendment No. 2) Regulations, 2011<sup>c</sup> are revoked.

**Interpretation.**

2. The Interpretation (Guernsey) Law, 1948<sup>d</sup> applies to the interpretation of these Regulations as it applies to the interpretation of an enactment.

**Citation, commencement and extent.**

3. (1) These Regulations may be cited as the Social Insurance (Benefits) (Amendment) Regulations, 2013 and shall come into force on the 8<sup>th</sup> January, 2013.

(2) These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.
