THE FURNITURE (MAXIMUM PRICES) (BAILLIWICK OF GUERNSEY)
(AMENDMENT NO. 2) ORDER, 1952.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Furniture (Maximum Prices) (Bailiwick of Guernsey) Order, 1951 (a), as amended (b), shall have effect subject to the amendment that to Section 8 of Part I of the First Schedule thereto there shall be added the items specified in the Schedule to this Order.
2. The Interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.
3. This Order may be cited as The Furniture (Maximum Prices) (Bailiwick of Guernsey) (Amendment No. 2) Order, 1952, and shall come into operation on the 26th day of March, 1952.
