The Board of Administration in pursuance of its powers under the Import and Export (Control) (Guernsey) Law, 1946, hereby orders as follows:-

- (1) the importation of racing or other pigeons from the United Kingdom, Jersey, the other Islands of this Bailiwick and the Isle of Man is hereby prohibited save under the authority of a licence issued by the States Committee for Agriculture and Fisheries;
- (2) the exportation of racing or other pigeons to the United Kingdom, Jersey, the other Islands of this Bailiwick and the Isle of Man is hereby prohibited save under the authority of a licence issued by the States Committee for Agriculture and Fisheries;
- (3) the importation of cats and dogs from the Island of Jersey is hereby prohibited;
- (4) the Delegation of Power to grant Import Licences (No. 1) Order, 1949, (a) shall be amended by inserting the item "Racing or other pigeons to the States Committee for Agriculture and Fisheries";
- (5) the Delegation of Power to grant Export Licences (No. 1) Order, 1949, (b) shall be amended by inserting the item "Racing or other pigeons to the States Committee for Agriculture and Fisheries";
- (6) the Import and Export (Control) (Guernsey) Order, 1949, Amendment No. 2 Order, 1952, dated the 6th day of May, 1952, is hereby revoked;
- (7) the interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of an enactment;
- (8) this Order shall come into force on the 18th day of June, 1952, and may be cited as The Import and Export (Control) (Guernsey) Order, 1949, Amendment No. 5 Order, 1952.
