THE MEAT (RATIONING) (BAILLIWICK OF GUERNSEY) (AMENDMENT) ORDER, 1952.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively, in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Meat (Rationing) (Bailiwick of Guernsey) Order, 1952 (a) shall be amended by substituting for paragraphs 1, 2 and 4 of the Schedule thereto (which specifies the amount of the meat ration) the following paragraphs:-

"1. Amount against the appropriate coupons relating to each week in a -

4. Amount against an appropriate coupon on a form R.G.44. 2s. 1d. maximum retail price".

2. Notwithstanding anything contained in Article 1 of this Order or in Article 4 (1) of the Meat (Rationing) (Bailiwick of Guernsey) Order, 1952, the maximum quantity of meat which may be obtained or supplied against an appropriate coupon for meat in any of the ration documents mentioned in Article 1 of this Order relating to the week beginning 8th June, 1952, and valid for use during that week and the following week, but not used during the said week beginning 8th June, 1952, shall be 2s. 1d. maximum retail price in the case of any appropriate coupon on a form R.G.44 and 9d. maximum retail price in any other case.

3. The Interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.

4. This Order may be cited as the Meat (Rationing) (Bailiwick of Guernsey) (Amendment) Order, 1952, and shall come into operation on the 15th day of June, 1952.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport.)

This Order amends the Meat (Rationing) (Bailiwick of Guernsey) Order, 1952.

In consequence of the increase in the maximum retail price of meat from 15th June, 1952, the value of the meat coupon on a form R.G.44 has been increased from that date from 1s. 10d. to 2s. 1d. maximum retail price. Any such coupon relating to the week beginning 8th June, 1952, but not used in that week will be valid if used in the week beginning 15th June, 1952, for 2s. 1d. maximum retail price.

This Order also increases, from 15th June, 1952, the amount of the meat ration which may be obtained against appropriate coupons in a Ration Book R.B.1 and Form R.B.12 from 1s. 3d. to 1s. 8d. maximum retail price. The value of the appropriate coupons in the Child's Ration Book R.B.2, Ration Book R.B.7 and Leave or Duty Ration Card R.B.8A is increased from 7½d. to 10d. as from the same date.

In consequence of the increase in the maximum retail prices of meat from 15th June, 1952, each coupon for meat in Ration Books R.B.1, R.B.2 and R.B.7 and Leave or Duty Ration Card R.B.8A relating to the week beginning 8th June, 1952, but not used in that week will be valid if used in the week beginning 15th June, 1952, for 9d. maximum retail price.
