THE UTILITY APPAREL (MAXIMUM PRICES AND CHARGES) (BAILLIWICK OF GUERNSEY) (AMENDMENT) ORDER, 1951.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) Order, 1951 (a) shall have effect subject to the amendment that for the Third Schedule thereto there shall be substituted the Schedule to this Order.
2. The Interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.
3. This Order may be cited as The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) (Amendment) Order, 1951, and shall come into operation on the 21st day of March, 1951.

EXPLANATORY NOTE.

This Order amends The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) Order, 1951, by bringing into force the following Related Schedules:-

Related Schedule 3H.	Women's and maids' outerwear (other than knitted apparel and gloves).
Related Schedule 4K.	Women's and maids' underwear and nightwear (other than knitted apparel).
Related Schedule 6L.	Knitted apparel (nylon hose).
Related Schedule 16C.	Gaberdine Raincoats.
Related Schedule 17A.	Women's domestic overalls and aprons.
