THE UTILITY CLOTH AND UTILITY HOUSEHOLD TEXTILES (MAXIMUM PRICES) (BAILLICK OF GUERNSEY) (AMENDMENT) ORDER, 1951.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Utility Cloth and Utility Household Textiles (Maximum Prices) (Bailiwick of Guernsey) Order, 1951 (a) shall have effect subject to the following amendments:-
 - (a) for items 13 and 15 of Part I of the First Schedule to that Order there shall be substituted the items so numbered in the First Schedule to this Order;
 - (b) to the specification numbers set out in Section A of Part II of the said First Schedule there shall be added the specification numbers set out in the Second Schedule hereto;
 - (c) to the specification numbers set out in Section B of Part II of the said First Schedule there shall be added the specification numbers set out in the Third Schedule hereto;
 - (d) the Fourth Schedule to this Order shall be added as a Fifth Schedule to that Order.
2. The Interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.
3. This Order may be cited as The Utility Cloth and Utility Household Textiles (Maximum Prices) (Bailiwick of Guernsey) (Amendment) Order, 1951, and shall come into operation on the 21st day of March, 1951.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order amends The Utility Cloth and Utility Household Textiles (Maximum Prices) (Bailiwick of Guernsey) Order, 1951, by -

- (a) providing maximum prices for seventy-two new descriptions of rayon dress and blouse cloths and twenty-five new descriptions of rayon lingerie, fabrics and linings,
- (b) reducing retailers' permitted margins for utility blankets of wool or other animal fibre of a description other than those set out in the Fifth Schedule to the Principal Order.
