THE UTILITY APPAREL (MAXIMUM PRICES AND CHARGES) (BAILLIWICK OF GUERNSEY) (AMENDMENT NO. 5) ORDER, 1951.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) Order, 1951 (a) as amended (b) shall have effect subject to the amendment that for the Third Schedule thereto, there shall be substituted the Schedule to this Order.
2. The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) (Amendment No. 4) Order, 1951, dated 19th June, 1951 (c) is hereby revoked.
3. The Interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.
4. This Order may be cited as The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) (Amendment No. 5) Order, 1951, and shall come into operation on the 9th day of July, 1951.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order amends The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) Order, 1951, as amended, by bringing into force Related Schedules Nos. 4M and 16D, which contain overriding maximum prices for Women's and maids' underwear and nightwear (other than knitted apparel) and Gaberdine raincoats respectively; it also brings into force Supplement No. 1 to Related Schedule No. 17A which contains overriding maximum prices for Women's domestic overalls and aprons.

The changes effected by the Related Schedules and the Supplement are indicated in the Explanatory Notes issued therewith.
