THE UTILITY CLOTH AND UTILITY HOUSEHOLD TEXTILES (MAXIMUM PRICES) (BAILLIWICK OF GUERNSEY) (NO. 2) (AMENDMENT) ORDER, 1951.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Utility Cloth and Utility Household Textiles (Maximum Prices) (Bailiwick of Guernsey) (No. 2) Order, 1951 (a) shall have effect as if for the prices specified in Part I of the Third Schedule to that Order in relation to goods of the descriptions specified in the Schedule to this Order there were substituted respectively the prices specified in the Schedule to this Order in relation to those descriptions.
2. The Interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.
3. This Order may be cited as The Utility Cloth and Utility Household Textiles (Maximum Prices) (Bailiwick of Guernsey) (No. 2) (Amendment) Order, 1951, and shall come into operation on the 3rd day of September, 1951.
