THE SOAP (MAXIMUM RETAIL PRICES) (BAILLIWICK OF GUERNSEY)
(AMENDMENT NO. 2) ORDER, 1951.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Soap (Maximum Retail Prices) (Bailiwick of Guernsey) Order, 1951 (a) as amended (b), shall be further amended by substituting in Part II of the Schedule thereto for item 15 relating to Messrs. Cussons, Sons & Co. Ltd's soaps; item 30 relating to Messrs. A. & F. Pears Ltd's soaps and item 38 relating to Messrs. Yardley & Co. Ltd's soaps, the items so numbered in the Schedule to this Order.
2. The Interpretation (Guernsey) Law, 1948, applies to the interpretation of this Order as it applies to the interpretation of a Guernsey enactment.
3. This Order may be cited as The Soap (Maximum Retail Prices) (Bailiwick of Guernsey) (Amendment No. 2) Order, 1951, and shall come into force on the 12th day of October, 1951.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport.)

This Order increases the maximum retail prices of certain brands of toilet soap and fixes maximum retail prices for certain new brands.
