THE UTILITY CLOTH AND UTILITY HOUSEHOLD TEXTILES (MAXIMUM PRICES)
(BAILLIWICK OF GUERNSEY) (AMENDMENT NO. 4) ORDER, 1950.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

- S.I. 86
1. The Utility Cloth and Utility Household Textiles (Maximum Prices) (Bailiwick of Guernsey) Order, 1949, as amended, shall have effect subject to the following amendments:-
 - (a) to section A of Part II of the First Schedule thereto there shall be added the specification numbers 6002/2, 6003/1 and 6003/2;
 - (b) for the Second Schedule thereto there shall be substituted the Schedule to this Order;
 - (c) in Part I of the First Schedule thereto, for the references in items 13 and 14 to Related Schedule No. 6M there shall be substituted references to Related Schedule No. 6N; and
 - (d) in the second column of the Fourth Schedule thereto, for the words "Maximum Price (Retailer)" there shall be substituted the words "Maximum Price (Retailer) per linear yard".
 2. The Utility Cloth and Utility Household Textiles (Maximum Prices) (Bailiwick of Guernsey) (Amendment No. 2) Order, 1949, is hereby revoked.
 3. This Order may be cited as The Utility Cloth and Utility Household Textiles (Maximum Prices) (Bailiwick of Guernsey) (Amendment No. 4) Order, 1950, and shall come into operation on the 13th day of February, 1950.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order amends The Utility Cloth and Utility Household Textiles (Maximum Prices) (Bailiwick of Guernsey) Order, 1949, as amended, which fixes retailers' maximum prices for utility cloth and utility household textiles, by -

- (a) adding to the goods to which that Order applies utility linen apparel cloths of the specification numbers 6002/2, 6003/1 and 6003/2 which have recently been introduced into the utility range; and
- (b) bringing into force -
 - (i) Supplement No. 3 to Related Schedule No. 5G (utility household textiles);
 - (ii) Related Schedule No. 6N (utility upholstery cloth and utility curtain cloth); and
 - (iii) Supplement No. 1 to Related Schedule No. 7B (utility cloth - lace and woven curtain net).

These Related Schedules set out overriding maximum prices for the goods to which they relate.
