THE UTILITY APPAREL (MAXIMUM PRICES AND CHARGES)  
(BAILLIWICK OF GUERNSEY) (AMENDMENT NO. 10) ORDER, 1950.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) Order, 1949, as amended (a), shall have effect as if for the Table set out in paragraph (1) of Article 6 thereof, there were substituted the Table set out in the Schedule to this Order.
2. The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) (Amendment No. 8) Order, 1950, dated 5th April, 1950, (b) is hereby revoked.
3. This Order may be cited as The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) (Amendment No. 10) Order, 1950 and shall come into operation on the 6th day of July, 1950.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order amends the Order fixing retailers' maximum prices for utility apparel by substituting Related Schedule No. 1J (Men's, youths' and boys' outerwear (other than knitted apparel and gloves)) for Related Schedule No. 1H and Supplements Nos. 1, 2 and 3 thereto and by adding a further Supplement, No. 2, to Related Schedule No. 4J (Women's and maids' underwear and nightwear (other than knitted apparel)).

The Related Schedules provide retailers' overriding maximum prices for the garments to which they relate.
