THE GENERAL FOOD (MAXIMUM RETAIL PRICES) (BAILLIWICK  
OF GUERNSEY) (AMENDMENT) ORDER, 1949.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The General Food (Maximum Retail Prices) (Bailiwick of Guernsey) Order, 1949, shall be amended as follows:-

(a) by substituting in Part II (Canned Condensed Milk) of the Schedule thereto for the maximum retail prices of "1/2d.", "1/1d." and "8d." as regards Special Full Cream Sweetened, Full Cream Sweetened and Machine Skimmed Sweetened respectively, the maximum retail prices of "1/3d.", "1/2d." and "9d.";

(b) by inserting in Part VIII (Syrup and Treacle) of the said Schedule, the following item:-

(c) by substituting in Part IX (Fats) of the said Schedule for the maximum retail price of "2/-" as regards Butter, imported, the maximum retail price of "2/4d.";

(d) by adding to the said Schedule as Part XIII thereof, relating to cheese, the part so numbered in the Schedule to this Order.

2. This Order may be cited as The General Food (Maximum Retail Prices) (Bailiwick of Guernsey) (Amendment) Order, 1949, and shall come into operation on the 6th day of June, 1949.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport).

This amending Order -

- (a) prescribes increased maximum retail prices for Special Full Cream Sweetened, Full Cream Sweetened and Machine Skimmed Sweetened Condensed Milk;
- (b) increases the maximum retail price of Imported Butter to 2/4d. per lb.;
- (c) prescribes a maximum retail price of 1/3d. per tin or carton of Syrup and Treacle in tins or cartons containing 1 lb. 9 oz. net weight; and
- (d) prescribes a maximum retail price of 1/8d. per lb. for Processed cheese and other varieties of cheese to which The Fats, Cheese and Tea (Rationing) (Bailiwick of Guernsey) Order, 1949, applies.
