THE UTILITY APPAREL (MAXIMUM PRICES AND CHARGES) (BAILLIWICK OF GUERNSEY) (AMENDMENT NO. 2) ORDER, 1949.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) Order, 1949, as amended, shall be further amended by substituting for the Table set out in paragraph (1) of Article 6 thereof, the Table set out in the Schedule hereto. - 1632
2. The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) (Amendment) Order, 1949, dated 13th June, 1949, is hereby revoked. - S.F. 12
3. This Order may be cited as The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) (Amendment No. 2) Order, 1949, and shall come into operation on the 8th day of July, 1949.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order amends The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) Order, 1949, as amended, by omitting Related Schedules No. 8H (Gloves) No. 9D (Merchant Navy clothing), No. 10D (Oilskins), No. 11E (Waterproofs), No. 12C (Nurses' uniforms), No. 13C (Fur apparel), No. 14D (Braces) and No. 15C (Corsets and brassieres), which provided overriding maximum prices. Consequently the maximum prices to be charged by a retailer for such utility apparel are now to be computed solely by reference to the price paid together with the appropriate percentage.

The Order also brings into force Supplement No. 2 to Related Schedule No. 3F (Women's and Maids' outerwear other than knitted apparel and gloves) and Supplement No. 3 to Related Schedule No. 7C (Infants' and girls' apparel other than knitted apparel and gloves).
