THE FOOD RATIONING (GENERAL PROVISIONS) (BAILLIWICK OF GUERNSEY) (AMENDMENT) ORDER, 1949.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Food Rationing (General Provisions) (Bailiwick of Guernsey) Order, 1949, shall be amended as follows:-
    - (a) by adding at the end of sub-paragraph (b) of the definition of "ration document" in paragraph (1) of Article 1 thereof the words "or Personal Points Page R.B.11 or R.B.11S";
    - (b) by inserting in proviso (ii) of sub-paragraph (a) of Article 4 thereof after the words "in respect of tea" the words ", personal points foods";
    - (c) by inserting in paragraph (1) of Article 6 thereof after the words "or Ration Book R.B.7" the words "not being coupons from a page marked 'Personal Points'.";
    - (d) by adding to sub-paragraph (f) of Article 8 thereof the following item:-

"(iii) chocolate, chocolate confectionery and sugar confectionery.";
    - (e) by adding at the end of sub-paragraph (a) of paragraph (10) of Article 11 thereof the words "other than coupons relating to personal points foods";
    - (f) by inserting in sub-paragraph (a) of paragraph (1) of Article 14 thereof after the words "any such coupon relating to tea" the words ", personal points foods";
    - (g) by inserting in sub-paragraph (a) of paragraph (5) of Article 18 thereof after the words "any appropriate coupon for tea" the words ", personal points foods";
    - (h) by inserting in sub-paragraph (b) of Article 29 thereof after the words "points rationed foods" the words "or personal points foods";
    - (i) by adding to Article 29 thereof the following sub-paragraph:-

"(e) the supply of personal points foods to members of the forces of His Majesty or of His Majesty's Allies or co-belligerents by any person who has been specially authorised by or on behalf of the Committee to obtain the personal points foods for that purpose, and the obtaining from such persons of personal points foods by members of the said forces."
  2. This Order may be cited as The Food Rationing (General Provisions) (Bailiwick of Guernsey) (Amendment) Order, 1949, and shall come into operation on the 14th day of August, 1949.
