THE UTILITY APPAREL (MAXIMUM PRICES AND CHARGES) (BAILLIWICK OF GUERNSEY) (AMENDMENT NO. 5) ORDER, 1949.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) Order, 1949, as amended, shall have effect subject to the following amendments:-
 - (a) in item 12 (a) (ii) of the Table set out in Article 2 there shall be added the words "not being boys' jerseys or pullovers";
 - (b) in item 12 (e) of the Table set out in Article 2 there shall be added the words "and boys' jerseys and pullovers";
 - (c) for the Table set out in paragraph (1) of Article 6 there shall be substituted the Table set out in the Schedule to this Order.
2. The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) (Amendment No. 2) Order, 1949, dated 5th July, 1949, and The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) (Amendment No. 3) Order, 1949, dated 9th August, 1949, are hereby revoked.
3. This Order may be cited as The Utility Apparel (Maximum Prices and Charges) (Bailiwick of Guernsey) (Amendment No. 5) Order, 1949, and shall come into operation on the 2nd day of November, 1949.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order amends the principal Order -

- (a) by making it clear that the retailers' margin on boys' utility jerseys and pullovers is 37.94 per cent of the purchase price; and
- (b) by bringing into force a Supplement to each Related Schedule issued for the purposes of the principal Order.
