THE IMPORTED ANIMAL FEEDINGSTUFFS (MAXIMUM PRICES) (BAILLIWICK OF GUERNSEY) ORDER, 1949.

As Competent Authorities as regards the Bailiwick of Guernsey excluding the Island of Alderney and as regards the Island of Alderney respectively in relation to Regulation 55 of the Defence (General) (Guernsey) Regulations, 1945, we hereby make the following Order:-

1. In this Order -

"Buy" includes offer or agree to buy and "sell" includes offer or agree to sell or expose for sale;

"Imported animal feedingstuffs" means any animal feedingstuffs of a description appearing in the Schedule to this Order which have been imported into the Bailiwick of Guernsey.

2. No person shall buy or sell any imported animal feedingstuffs of a description appearing in the Schedule to this Order at a price exceeding the price applicable thereto in accordance with the provisions of the said Schedule.

3. The Imported Animal Feedingstuffs (Maximum Prices) (Guernsey) Order, 1948, dated 22nd January, 1948 and The Imported Animal Feedingstuffs (Maximum Prices) (Guernsey) (Amendment No. 11) Order, 1949, dated 4th November, 1949, are hereby revoked but without prejudice to any proceedings in respect of any contravention thereof. - 1142

4. This Order may be cited as The Imported Animal Feedingstuffs (Maximum Prices) (Bailiwick of Guernsey) Order, 1949, and shall come into operation on the 28th day of November, 1949.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport).

The Imported Animal Feedingstuffs (Maximum Prices) (Guernsey) Order, 1948, as amended, fixed maximum prices for animal feedingstuffs sold in Guernsey. This Order, which revokes and re-enacts that Order, prescribes maximum prices in respect of sales both in Guernsey and Alderney. There are no changes in the Guernsey prices but a separate schedule prescribes maximum prices for certain descriptions of animal feedingstuffs now on sale in Alderney. It should be noted that the high price of animal feedingstuffs in Alderney as compared with similar products in Guernsey is due to the subsidy being charged to the farmer and claimed back from the States whereas in Guernsey feedingstuffs are charged out at subsidized prices.
