## **The Tourism (Accommodation Permits) (Fees) (Sark) Ordinance, 2008**

**THE CHIEF PLEAS OF SARK**, in pursuance of their Resolution of the 18<sup>th</sup> January, 2007, and in exercise of the powers conferred on them by sections 7 and 19 of the Tourism (Sark) Law, 1982<sup>a</sup> and all other powers enabling them in that behalf, hereby order: –

### **Increase of fees.**

1. (1) The fee payable to the Treasurer under section 7 of the Tourism (Sark) Law, 1982 in respect of the grant of an accommodation permit shall, for the year 2008, be the sum (for each of the number of persons authorised to be accommodated in the premises or on the site) set out in the second column of the table in the Schedule to this Ordinance which corresponds to the category of accommodation set out in the first column of the said table.

**Interpretation.**

2. (1) The Interpretation (Guernsey) Law, 1948<sup>b</sup> applies to the interpretation of this Ordinance.

(2) Any reference in this Ordinance to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

## SCHEDULE

Section 1

Category of accommodation	Fee per person
Hotel	£7.50
Guest House	£6.00
Self- catering	£5.25
Camp sites	£3.00

**NOTE**

*In accordance with the provisions of the Tourism (Accommodation Permits) (Fees) (Sark) (No. 2) Ordinance, 2008, section 1(1), with effect from 2nd July, 2008, the fee specified herein may, in respect of the year 2009 and each succeeding year, be subject to an increase not greater than the annual percentage increase, if any, in the Guernsey Index of Retail Prices most recently published in a Billet d'État before the end of the preceding calendar year; and, in accordance with section 1(2) of the 2008 (No. 2) Ordinance, with effect from that same date, any increase imposed under section 1(1) thereof may apply to all or any of the categories of accommodation set out in the first column of the Table herein and different increases may be applied to different categories.*
