The Import (Control) (Alderney) (Amendment) Order, 2013

Made

24th September 2013

Coming into operation

1st October 2013

The States of Alderney Policy and Finance Committee, in pursuance of the powers conferred upon it by Article 1 of the Import and Export (Control) (Alderney) Law, 1946^a, **HEREBY ORDERS:-**

Amendment to Order of 2010.

1. Schedule 8 to the Import (Control) (Alderney) Order, 2010^b is amended by substituting, for paragraph 17, the following paragraphs –

- "17. (a) Ethyl phenyl(piperidin-2-yl)acetate (also known as 'ethylphenidate'),
- (b) any stereoisomeric form of ethyl phenyl(piperidin-2-yl)acetate,
- (c) any salt of a substance specified in subparagraph (a) or (b), or

- (d) any preparation or other product containing a substance specified in any of subparagraphs (a) to (c).
- 17A.
- (a) Any compound structurally derived from 2-(2,5-dimethoxyphenyl)-*N*-(2-methoxybenzyl)ethanamine by substitution in the phenethylamine ring to any extent with an alkyl group or halide substituents,
 - (b) 5-(2-aminopropyl)benzofuran or 6-(2-aminopropyl)benzofuran whether or not modified in either of the following ways –
 - (i) by saturation of the benzofuran ring at the 2-position, or
 - (ii) by substitution at the nitrogen atom with methyl or ethyl groups,
 - (c) 1-(1*H*-indol-5-yl)propan-2-amine or 1-(1*H*-indol-6-yl)propan-2-amine whether or not substituted at the nitrogen atom in the side chain with methyl or ethyl groups,
 - (d) any stereoisomeric form of a substance specified in any of subparagraphs (a) to (c),
 - (e) any salt of a substance specified in any of subparagraphs (a) to (d), or
 - (f) any preparation or other product containing a substance or product specified in any of subparagraphs (a) to (e)."

Interpretation.

2. (1) In this Order, a reference to any enactment is a reference to the enactment as from time to time amended, varied, re-enacted (with or without modification), extended or applied.

(2) The provisions of the Interpretation (Guernsey) Law, 1948^c apply to the interpretation of this Order throughout the Island of Alderney as they apply to the interpretation of an enactment in force in the Island of Guernsey.

Consequential revocation.

3. The Import (Control) (Alderney) (Amendment No. 2) Order, 2012^d is revoked.

Citation.

4. This Order may be cited as the Import (Control) (Alderney) (Amendment) Order, 2013.

Commencement.

5. This Order comes into force on the 1st October, 2013.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the list of prohibited imports in Schedule 8 to the Import (Control) (Alderney) Order, 2010.

Methoxetamine and related substances are removed from that list of prohibited imports, as these substances would be listed as a Class B drug in the Misuse of Drugs (Bailiwick of Guernsey) Law, 1974 under the Misuse of Drugs (Modification) Order, 2013.

Ethyl phenyl(piperidin-2-yl)acetate (also known as 'ethylphenidate'), 6-(2-aminopropyl)benzofuran (also known as 'benzofury'), and related substances are added to that list of prohibited imports.

This Order comes into force on the 1st October, 2013.
