## The External Companies (Fees) Regulations, 2013

**THE STATES OF ALDERNEY POLICY AND FINANCE COMMITTEE**, in exercise of the powers conferred upon it by sections 3(1)(j), 8 and 12 of The Companies (Alderney) Law (External Companies) Ordinance, 1998(a), hereby makes the following regulations:

### **Registration fee.**

1. For the purposes of section 3(1)(j) of The Companies (Alderney) Law (External Companies) Ordinance, 1998, the prescribed registration fee shall be £141.

### **Annual Fee.**

2. For the purposes of section 8 of The Companies (Alderney) Law (External Companies) Ordinance, 1998, the prescribed annual fee shall be £100.

### **Fees for inspection of Register.**

3. For the purposes of section 12 of The Companies (Alderney) Law (External Companies) Ordinance, 1998 –

(a) the prescribed fee for an inspection of –

- (i) the Register of External Companies or any document filed therein; or
- (ii) any former entry in the said Register and any document formerly filed therein in relation to a company the name of which has been removed from the said Register;

shall be £13 per company;

(b) the prescribed fee for the supply by the Register of a copy of any document described in paragraph (a) shall be £1.25 per A4 side.

## **Interpretation.**

4. (1) In these Regulations expressions shall, except where the context excludes, have the same meanings as in The Companies (Alderney) Law (External Companies) Ordinance, 1998.

(2) The provisions of The Interpretation (Guernsey) Law, 1948(b) shall apply to the interpretation of these Regulations as they apply in Guernsey to the interpretation of a Guernsey enactment.

(3) Any reference in these Regulations to an enactment or statutory instrument is a reference thereto as from time to time amended, replaced or re-enacted (in either case, with or without modification), extended or applied.

## **Repeal.**

5. The External Companies (Fees) Regulations, 2012 (c) are hereby repealed.

## **Citation.**

6. These Regulations may be cited as The External Companies (Fees) Regulations, 2013.

## **Commencement.**

7. These Regulations shall come into force on 26<sup>th</sup> November 2013..
