**The Copyright (Application to the United Kingdom)  
(Bailiwick of Guernsey) Regulations, 2014**

**THE COMMERCE AND EMPLOYMENT DEPARTMENT**, in exercise of the powers conferred on it by sections 185 and 221 of the Copyright (Bailiwick of Guernsey) Ordinance, 2005<sup>a</sup> and all other powers enabling it in that behalf, hereby makes the following Regulations:-

**Application to the United Kingdom.**

1. Section 182 (qualification by reference to author) of the Ordinance applies in relation to –

- (a) persons who are domiciled or resident in any part of the United Kingdom as it applies to persons who are British citizens domiciled or resident in the Bailiwick, and
- (b) bodies incorporated under the law of any part of the United Kingdom as it applies in relation to bodies incorporated under the law of the Bailiwick.

2. Section 183 (qualification by reference to country of first publication) of the Ordinance applies in relation to works first published in the United Kingdom as it applies in relation to works first published in the Bailiwick.

3. Section 184 (qualification by reference to place of transmission) of the Ordinance applies in relation to broadcasts made from the United Kingdom as it applies in relation to broadcasts made from the Bailiwick.

**Interpretation.**

4. (1) In these Regulations, unless the context requires otherwise –

"the Ordinance" means the Copyright (Bailiwick of Guernsey) Ordinance, 2005,

and other expressions have the same meanings as in the Ordinance.

(2) The Interpretation (Guernsey) Law, 1948<sup>b</sup> applies to the interpretation of these Regulations.

(3) Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

**Extent.**

5. These Regulations have effect throughout the Bailiwick.

**Citation and commencement.**


6. These Regulations may be cited as the Copyright (Application to the

#### EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations apply the provisions of the Copyright (Bailiwick of Guernsey) Ordinance, 2005, to all works originating in the United Kingdom, whether by reference to their author's residence or domicile, the country of first publication or the place of transmission.

These Regulations come into force on the 18<sup>th</sup> February, 2014.
