The Guernsey Social Security Authority (Transfer of Functions) Ordinance, 1993

THE STATES, in pursuance of their Resolution of the 30th day of June, 1993^a, and in exercise of the powers conferred upon them by section 1 of the Public Functions (Transfer and Performance) (Bailiwick of Guernsey) Law, 1991^b, hereby order: –

Transfer of functions to Social Security Authority.

1. The functions of the States Insurance Authority under the enactments set out in Schedule 1 are hereby transferred to the Guernsey Social Security Authority.

NOTE

In accordance with the provisions of the Machinery of Government (Transfer of Functions) (Guernsey) Ordinance, 2003, section 2, Schedule 1, paragraph 26, with effect from 6th May, 2004, the Guernsey Social Security Authority was replaced by the Guernsey Social Security Authority; and the functions, rights and liabilities of the Social Security Authority and of its President arising under or by virtue of this Ordinance were transferred to and vested in, respectively, the Social Security Department and its Minister by the Machinery of Government (Transfer of Functions) (Guernsey) Ordinance, 2003, section 1, Schedule 1, paragraph 26, with effect from 6th May, 2004, subject to the savings and transitional provisions in section 4 of the 2003 Ordinance. In accordance with the provisions of the Organisation of States' Affairs (Transfer of Functions) Ordinance, 2016, section 2, Schedule 1, paragraph 13, with effect from 1st May, 2016, the , the Social Security Department has since been replaced by the Committee for Employment & Social Security; and the functions, rights and liabilities of

the Social Security Department and of its Minister or Deputy Minister arising under or by virtue of this Ordinance were transferred to and vested in, respectively, the Committee for Employment & Social Security and its President or Vice-President by the Organisation of States' Affairs (Transfer of Functions) Ordinance, 2016, section 1, Schedule 1, paragraph 13, with effect from 1st May, 2016, subject to the savings and transitional provisions in section 3 of the 2016 Ordinance.

Savings.

2. (1) Anything done by or in relation to the States Insurance Authority under any enactment set out in Schedule 1 before the commencement of this Ordinance shall have effect as if done by or in relation to the Guernsey Social Security Authority.

(2) Anything in the process of being done by or in relation to the States Insurance Authority under any enactment set out in Schedule 1 at the date of the commencement of this Ordinance may be continued by or in relation to the Guernsey Social Security Authority.

Amendments.

3. The enactments set out in Schedule 2 are amended as therein mentioned.

4. Any reference in this Ordinance to an enactment is a reference thereto as amended, extended or applied.

Citation.

5. This Ordinance may be cited as the Guernsey Social Security Authority (Transfer of Functions) Ordinance, 1993.

SCHEDULE 2
AMENDMENTS
