## The Boarding Permit Fees Order, 2014

<i>Made</i>	<i>4<sup>th</sup> February, 2014</i>
<i>Coming into operation</i>	<i>1<sup>st</sup> April, 2014</i>
<i>Laid before the States</i>	<i>2014</i>

THE COMMERCE AND EMPLOYMENT DEPARTMENT, in exercise of the powers conferred on it by section 17 of the Tourist Law, 1948<sup>a</sup> as amended<sup>b</sup> and all other powers enabling it in that behalf, hereby orders:-

### Fee payable by applicants for a boarding permit.

1. An applicant for a boarding permit shall pay to the Department on application for a permit valid from 1<sup>st</sup> April 2014 to 31<sup>st</sup> March 2015, or part thereof, a fee of £8.00 multiplied by the maximum number of persons for whom the applicant seeks permission to provide sleeping accommodation for reward.

### Interpretation.

2. (1) In this Order, unless the context requires otherwise –
- (a) “**the Law**” means the Tourist Law, 1948; and
  - (b) “**Department**” means the Commerce and Employment Department.

(2) The Interpretation (Guernsey) Law, 1948<sup>c</sup> applies to the interpretation of this Order.

(3) Any reference in this Order to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

**Repeal.**

3. The Boarding Permit Fees Order, 2012 is repealed.<sup>d</sup>

**Citation.**

4. This Order may be cited as the Boarding Permit Fees Order, 2014.

**Commencement.**

5. This Order comes into force on the 1<sup>st</sup> April, 2014.
