**The [Severe Disability Benefit and Carer's Allowance
(Guernsey) Law, 1984 (Commencement) Ordinance, 1985]**

THE STATES, in exercise of the powers conferred upon them by section 28 of the [Severe Disability Benefit and Carer's Allowance (Guernsey) Law, 1984]^a, hereby order: –

Commencement of the Law of 1984.

1. The [Severe Disability Benefit and Carer's Allowance (Guernsey) Law, 1984], shall come into force on the 6th day of January, 1986.

NOTES

Extent.

2. This Ordinance shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

3. This Ordinance may be cited as the Severe Disability Benefit and Carer's Allowance (Guernsey) Law, 1984 (Commencement) Ordinance, 1985.]
