## **The [Severe Disability Benefit and Carer's Allowance (Amendment) (Guernsey) Law, 1986]**

**THE STATES**, in pursuance of their Resolution of the 27<sup>th</sup> day of November, 1985, have approved the following provisions which, subject to the Sanction of Her Most Excellent Majesty in Council, shall have force of law in the Islands of Guernsey, Alderney, Herm and Jethou.

### **Amendment to Law of 1984.**

**1.** Section 2(3) of the [Severe Disability Benefit and Carer's Allowance (Guernsey) Law, 1984] (hereinafter referred to as "**the principal Law**")<sup>a</sup>, is hereby amended as follows –

- (a) paragraph (b) thereof is repealed,
- (b) in paragraph (d) immediately after the words "any periodic payment" there are inserted the words ", other than an old age pension,"<sup>1</sup>
- (c) paragraphs (c) and (d) are renumbered as paragraphs "(b)" and "(c)" respectively.
