The [Severe Disability Benefit and Carer's Allowance (Amendment) (Guernsey) Law, 1991]

THE STATES, in pursuance of their Resolution of the 28th day of June, 1990^a, have approved the following provisions, which, subject to the Sanction of Her Most Excellent Majesty in Council, shall have force of law in the Islands of Guernsey, Alderney, Herm and Jethou.

Amendment.

1. Section 1(4)(a) of the [Severe Disability Benefit and Carer's Allowance (Guernsey) Law, 1984], as amended^b, is repealed.

NOTES
