The Parking Places (Amendment) Order, 2014

Coming into operation

30th June, 2014

THE ENVIRONMENT DEPARTMENT, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended^a, hereby orders:-

1. The Parking Places Order, 1991, as amended^b, is further amended as follows.
2. In Part C of Schedule 1, in the third column relating to Disc Parking Place No. DC12, immediately following the words "The west side of the road" insert, ", but excluding Approved Parking Place No. AC68".
3. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA8, immediately following the words "junction with St Stephen's Lane" insert, ", but excluding Approved Parking Place No. AC69".
4. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA32a, the word "portion" is substituted with the word "portions".
5. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA53, immediately following the words "On the roads of the estates" insert, ", but excluding Approved Parking Place No. AC72".

6. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA69, the words, "and AC40" are substituted with the words ", AC40 and AC70".

7. In Part C of Schedule 2, delete the entries relating to Approved Parking Place Nos. AC54 and AC63.

8. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC67 insert the following entries –

"AC68	Clifton	The portion of the west side of the road, directly opposite the house named La Vedure, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.
AC69	Stanley Road	The portion of the northern side of the road, near to its junction with St Stephen's Lane, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.
AC70	Les Genats Estate, Castel	The portion of the road as near as practical to No. 5 within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.
AC71	Avenue Vivier	The portion of road adjacent to the property known as The Birches, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge
AC72	Sausmarez Mill Estate, St Martins	The portion of the road as near as practical to No. 51 within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

9. This Order may be cited as the Parking Places (Amendment) Order, 2014.

10. This Order shall come into force on the 30th June, 2014.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking Places Order, 1991, as amended. It allocates new disabled bays in approved parking places Nos. AC68, AC69, AC70, AC71 and AC72 (Clifton, Stanley Road, Les Genats Estate, Avenue Vivier and Sausmarez Mill Estate respectively as further specified in this Order), removes disabled bays in approved parking place Nos. AC54 and AC63 (both New Place as further specified in this Order), and introduces additional 23-hour approved parking at Route des Coutures, Vale.

This Order comes into force on the 30th day of June, 2014.
