**The Air Navigation (Restriction of Flying) (Bailiwick of
Guernsey) Air Display Regulations, 2014**

THE DIRECTOR OF CIVIL AVIATION, in exercise of the powers conferred on him by section 35(1)(b) of the Air Navigation (Bailiwick of Guernsey) Law, 2012^a and all other powers enabling him in that behalf, hereby makes the following Regulations:-

Restriction of flying and access to Guernsey Airport.

1. The airspace having lateral limits of a circle radius of 10 nautical miles centred on St Peter Port, Guernsey (N 049 2718.1710 W 002 3127.0479) and vertical limits of the surface to Flight Level 120, is classified as Class D Airspace from 0950 until 1225 hours (UTC) on Thursday 11th September 2014.
2. Guernsey Airport shall be closed from 0955 until 1220 hours (UTC) on Thursday 11th September 2014 to all aircraft except those mentioned in regulation 4(2).
3. Access to Guernsey Airport shall be by Prior Permission Only (PPO) to all aircraft except to scheduled services and to locally based aircraft between 0530 10th and 1800 on 11th September 2014, inclusive.

4. (1) Subject to paragraph (2), no aircraft shall, from 0950 until 1225 hours (UTC) on Thursday 11th September 2014, fly into the airspace below Flight Level 120 within a radius of four and a half nautical miles from position:

N 49 27 18.1710

W 002 31 27.0479

or take off from any place in that area.

(2) Paragraph (1) shall not apply to

- (a) any aircraft flying with the permission of the Manager, Air Traffic Control Guernsey,
- (b) any aircraft flying with the permission of the Guernsey Air Display Flying Display Director, or
- (c) any aircraft flying for the purpose of Search and Rescue or for the purpose of saving life.

Interpretation.

5. (1) The Interpretation (Guernsey) Law, 1948^b applies to the interpretation of these Regulations.

(2) Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.


(3) All times referred to in these Regulations are Universal Time Coordinated (UTC).

Citation and commencement.

6. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Bailiwick of Guernsey) Air Display Regulations, 2014 and shall come into force on 17 June, 2014

EXPLANATORY NOTE.

(This note is not part of the Regulations)

These regulations prohibit (subject to the granting of exemptions) all flights within four and a half miles of position:

N 49 27 18.1710

W 002 31 27.0479

between 0950 and 1225 hours UTC on the 1st September, 2014, by reason of an air display. They impose other restrictions on flying and the use of Guernsey Airport in order to enable the display to be undertaken safely.
