**THE HOME DEPARTMENT**, in exercise of the powers conferred upon it by section 5 of the Immigration and Asylum Act 1999 as extended to Guernsey by the Immigration and Asylum Act 1999 (Guernsey) Order 2003<sup>a</sup>, and by section 166(3) of the Immigration and Asylum Act 1999 as extended to Guernsey by the Immigration (Guernsey) Order 2011<sup>b</sup> hereby makes the following Order:-

**Amendment of the Order of 2014.**

1. (1) Article 5 of the Immigration and Asylum Act 1999 (Fees) (Bailiwick of Guernsey) (Amendment) Order, 2014<sup>c</sup> is amended by substituting, for "2013", "2014".

(2) The amendment made by paragraph (1) has effect only for the removal of doubt and is not to be construed as impliedly invalidating anything done in conformity with any enactment or rule of law, either before or after this Order comes into force.
