**The Public Records (Fees for Registration and Certified
Copies of Documents) Regulations, 2014**

Made , 2014

Coming into operation 1st January, 2015

Laid before the States , 2015

THE TREASURY AND RESOURCES DEPARTMENT, in exercise of the powers conferred on it by sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 2007^a as amended, and all other powers enabling it in that behalf, hereby makes the following regulations:-

Registration fees for documents.

1. In section 1 of the Public Records (Fees for Registration and Certified Copies of Documents) Ordinance, 1960^b ("the 1960 Ordinance") -

(a) in paragraph (a), for "£55" substitute "£60", and

(b) in paragraphs (b) and (c), for "£4.50" substitute "£5.00".

Fees for certified copies of documents.

2. In section 2 of the 1960 Ordinance -

- (a) in paragraph (a), for "£3.00" substitute "£3.50", and
- (b) in paragraph (b), for "£5.00" substitute "£5.50".

Fees for uncertified copies of registered documents.

3. In section 2A of the 1960 Ordinance -

- (a) in paragraphs (a) and (b)(ii), for "£1.50" substitute "£2.00", and
- (b) in paragraph (b)(i), for "£4.00" substitute "£4.50".

Fees in respect of documents creating charge on land.

4. In paragraphs (a) and (b) of section 2B of the 1960 Ordinance, for "£40" substitute "£50".

Interpretation.

5. Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Repeal.

6. The Public Records (Fees for Registration and Certified Copies of Documents) Regulations, 2012^c are repealed.


Citation.
