The Motor Vehicles (Sark) Regulations, 2014

<i>Made</i>	<i>27th August, 2014</i>
<i>Coming into operation</i>	<i>6th October, 2014</i>

THE SARK CHIEF PLEAS ROAD TRAFFIC COMMITTEE, in exercise of the powers conferred on it by sections 3, 4 to 7, 9, 12, 13 to 15, 17, 20 to 22, 24, 26, 27 to 31 and 41 of the Motor Vehicles (Sark), 2013^a, hereby orders:-

Tractor licences.

1. For the purposes of sections 3 to 5 of the Law, an applicant for a tractor licence and an applicant to renew a tractor licence shall make an application to the Committee in the relevant form set out in Schedule 1 to these Regulations, enclosing the fee referred to therein.

Tractor tax.

2. For the purposes of section 6 of the Law, the tax chargeable on the grant and renewal of a tractor licence is £100.

Vehicle inspector fee.

3. For the purposes of section 7(4) of the Law, the fee payable to a Vehicle Inspector is £9.

Maximum size of tractors.

4. For the purposes of section 9(2) of the Law, the maximum size of tractors that may be licensed under section 9 is as follows:

- (a) length 3.60 metres,
- (b) width 2 metres,
- (c) height 2.56 metres.

Marking of tractors.

5. (1) The owner of a tractor registered under section 12 of the Law shall be issued by the Committee with a licence disc, and he must place that disc on the near side of the tractor in a place that is easily visible by another road user.

(2) The owner of a tractor who has had a licence disc issued to him commits an offence if he breaches the requirements of paragraph (1).

(3) A person who commits an offence under this regulation shall be liable to a fine not exceeding level 2 on the uniform scale.

Tractor driving licences.

6. For the purposes of section 13 and section 15, an applicant for a tractor driving licence and an applicant to renew a tractor driving licence shall make an application to the Constable in the relevant form set out in Schedule 2 to these Regulations, enclosing the fee referred to therein.

Tractor driving tests.

7. For the purposes of section 14(1) of the Law, the tests of competency are those set in Schedule 3 to these Regulations.

Tractor driving licences: fees.

8. For the purposes of section 17 of the Law, the fee payable on the making of each application referred to therein at paragraphs (a) – (d) is £10.

Invalid carriages: applications for licences and driving licences.

9. (1) For the purposes of sections 20 and 22 of the Law, an applicant for an invalid carriage licence and an applicant to renew an invalid carriage licence shall make an application to the Committee in the relevant form set out in Schedule 4 to these Regulations.

(2) For the purposes of sections 21, 22 and 26 of the Law, an applicant for an invalid carriage driving licence, an applicant for a temporary invalid carriage driving licence and an applicant to renew an invalid carriage driving licence shall make an application to the Committee in the relevant form set out in Schedule 5 to these Regulations, enclosing the fee referred to therein.

Invalid carriages: conditions.

10. For the purposes of section 20(3) of the Law, an invalid carriage licence may contain a condition that the holder may not drive an invalid carriage between sunset and sunrise.

Invalid carriages: fees.

11. For the purposes of section 24 of the Law, the fees payable on the making of the applications referred to below are as follows –

- (a) grant and renewal of an invalid carriage licence: no fee,
- (b) grant of temporary invalid carriage driving licence: no fee,
- (b) grant and renewal of an invalid carriage driving licence: £20,
- (c) grant and renewal of an invalid carriage driving licence in respect of an electric bicycle: £11.

Construction vehicles.

12. (1) For the purposes of sections 27 and 28 of the Law, an applicant for an construction vehicle licence and an applicant to renew a construction vehicle licence shall make an application to the Committee in the relevant form set out in Schedule 6 to these Regulations, enclosing the fee referred to therein.

(2) For the purposes of section 29 of the Law, the fees payable on the making of the applications referred to therein are as follows –

- (a) grant of a construction vehicle licence: £100,
- (b) renewal of a construction vehicle licence: £100.

Tractor import licences.

13. For the purposes of section 30 of the Law, an applicant for a tractor import licence shall make an application to the Committee in the form set out in Schedule 7 to these Regulations.

Notification of importation of other motor vehicles.

14. (1) For the purposes of section 31 of the Law, in addition to notifying the Committee of the nature of the vehicle, a person importing into Sark a vehicle of a type described in section 31 shall notify the Committee of the use to which the vehicle shall be put, and where the vehicle will be kept.

(2) The Committee must be notified of the information set out above at least seven days before the vehicle is imported.

Interpretation.

15. (1) Expressions in these Regulations have the same meanings as in the Motor Vehicles (Sark) Law, 2013 ("**the Law**").

(2) The Interpretation (Guernsey) Law, 1948^b applies to the interpretation of these Regulations, as if they were an enactment.

(3) Any reference in these Regulations to the Law is a reference thereto as from time to time amended or re-enacted (with or without modification).

Citation and commencement.

16. These Regulations may be cited as the Motor Vehicles (Sark) Regulations, 2014 and shall come into force on the 6th October, 2014.
