**The Social Insurance (Benefits) (Amendment) Regulations,
2014**

THE SOCIAL SECURITY DEPARTMENT, in exercise of the powers conferred upon it by sections 15, 36, 39 and 116 of the Social Insurance (Guernsey) Law, 1978, as amended^a, and of all other powers enabling it in that behalf, hereby orders:-

Amendment.

1. The five schedules to the Social Insurance (Benefits) Regulations, 2003, as amended^b are revoked and replaced by the five schedules set out in the Schedule to these Regulations.

Interpretation.

2. (1) Except where the context otherwise requires, any reference in these Regulations to any enactment or regulations shall be construed as including a reference to that enactment or those regulations, as the case may be, as amended, repealed, replaced, revoked, extended or applied, by or under any other enactment or by any other regulations.

(2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of these Regulations as it applies to the interpretation of an enactment.

Revocation of 2013 Regulations.

3. The Social Insurance (Benefits) (Amendment No. 2) Regulations, 2013^d are revoked.

Citation, commencement and extent.

4. (1) These Regulations may be cited as the Social Insurance (Benefits) (Amendment) Regulations, 2014 and shall come into force on the 5th January, 2015.

(2) These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations amend the schedules to the Social Insurance (Benefits) Regulations, 2003 and prescribe the reduced rates of benefit payable from 5th January 2015 to claimants who do not satisfy the conditions for entitlement to payment of the maximum rate of benefit.

These Regulations come into operation on 5th January 2015.
