The Import (Control) (Alderney) (Amendment) Order, 2015

THE STATES OF ALDERNEY POLICY AND FINANCE COMMITTEE, in pursuance of the powers conferred upon it by Article 1 of the Import and Export (Control) (Alderney) Law, 1946^a, **HEREBY ORDERS:-**

Amendments to Order of 2010.

1. Schedule 8 to the Import (Control) (Alderney) Order, 2010^b is amended as follows -

- (a) immediately after paragraph 18 of the Schedule, insert the following paragraph -

"19. Any medicinal product that –

- (a) is or purports to be GcMAF, or
(b) contains or purports to contain GcMAF.",

and

- (b) in the Interpretation part of the Schedule, between the definition of "**Community Regulation**" and the definition of "**motor vehicle**", insert the following definition -

"**medicinal product**" has the meaning given to that expression by paragraphs 5 and 6 of Schedule 3 to this Order,".

Interpretation.

2. (1) In this Order, a reference to any enactment is a reference to the enactment as from time to time amended, varied, re-enacted (with or without modification), extended or applied.

(2) The provisions of the Interpretation (Guernsey) Law, 1948^c apply to the interpretation of this Order throughout the Island of Alderney as they apply to the interpretation of an enactment in force in the Island of Guernsey.

Citation.

3. This Order may be cited as the Import (Control) (Alderney) (Amendment) Order, 2015.

Commencement.

4. This Order comes into force on the 17th March, 2015.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Import (Control) (Alderney) Order, 2010 ("**the principal Order**").

Currently, the importation of any medicinal product is prohibited subject to the exceptions specified in Schedule 3 to the principal Order. As available information indicates that medicinal products that are or contain GcMAF may pose a significant risk to human health, the exceptions provided for in Schedule 3 are considered to be inappropriate for those products.

This Order inserts a new paragraph 19 in Schedule 8 (miscellaneous goods) to the principal Order, in order to specifically prohibit the importation of any medicinal product that is, purports to be, contains or purports to contain GcMAF. This Order also inserts a new definition in that schedule to define "**medicinal product**" by reference to the meaning given to that expression by paragraphs 5 and 6 of Schedule 3 (medicinal products) to the principal Order. The only exception to this import prohibition is if the importation of the product is authorised by an import licence granted by the States of Alderney Policy & Finance Committee under the principal Order.

This Order comes into force on the 17th March, 2015.
