The Parking Places (Amendment) Order, 2015

Made 27th

March, 2015

Coming into operation

30th March, 2015

THE ENVIRONMENT DEPARTMENT, in exercise of the powers conferred upon it by section 1(1) and (2) of the Road Traffic (Parking Places) Ordinance, 1963, as amended^a, and all other powers enabling it in that behalf, hereby orders:-

1. The Parking Places Order, 1991, as amended^b, is further amended as follows.

2. In Part C of Schedule 1, immediately following the entry relating to Disc Parking Place No. DC4aa insert the following entry -

"DC4ab	South Esplanade	40 parking spaces at the north eastern end of Disc Parking Place DE6 from 15 th March to 15 th October inclusive."

3. In Part E of Schedule 1, in the third column relating to Disc Parking Place No. DE6, immediately following the words "La Valette" insert, ", but excluding Disc Parking Place No. DC4ab from 15th March to 15th October inclusive".

4. In Part E of Schedule 2, immediately following the entry relating to Approved Parking Place No. AE2 insert the following entry –

"AE3	South Esplanade	The portion of the west side of the road, to the south of Picquet House within the limits indicated by signs from 15 th March to 15 th October inclusive."

5. In Part A of Schedule 1, in the third column relating to Disc Parking Place No. DA1, immediately following the words "and Les Echelons" insert, ", but excluding Approved Parking Place No. AE3 from 15th March to 15th October inclusive".

6. This Order may be cited as the Parking Places (Amendment) Order, 2015.

7. This Order shall come into force on the 30th March, 2015.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking Places Order, 1991, as amended. It allocates a new coach parking bay at South Esplanade on a seasonal basis that reverts to ½ hour disc parking for the remainder of the year, and provides for 40 10-hour disc parking places at Havelet to be 2 hour disc parking places on a seasonal basis.

This Order comes into force on the 30th day of March, 2015.
