THE STATES HOME DEPARTMENT, in exercise of the powers conferred on it by paragraph 4(2) of Schedule 4 to, and section 66(2) of, the Data Protection (Bailiwick of Guernsey) Law, 2001^a, and of all other powers enabling it and after consultation with the Data Protection Commissioner in accordance with section 66(3) of that Law, hereby makes the following order:-

Amendment of the 2002 Order.

1. In the definition of "**the Stock Exchange**" in article 2(3) (interpretation) of the Data Protection (Transfer in the Substantial Public Interest) Order, 2002^b, for "Channel Islands Stock Exchange LBG" substitute "Channel Islands Securities Exchange Authority Limited".

Interpretation.

2. (1) In this Order, unless the context requires otherwise -

"**enactment**" means any Law, Ordinance or subordinate legislation,
and

"**subordinate legislation**" means any regulation, rule, order, rule of
court, resolution, scheme, byelaw or other instrument made under any
enactment and having legislative effect.

(2) The Interpretation (Guernsey) Law, 1948^c applies to the
interpretation of this Order.

(3) Any reference in this Order to an enactment is a reference
thereto as from time to time amended, re-enacted (with or without modification),
extended or applied.


Citation and commencement.

3. This Order may be cited as the Data Protection (Transfer in the
Substantial Public Interest) (Amendment) Order, 2015 and shall come into force on
the 20th April, 2015.

EXPLANATORY NOTE
(This note is not part of the Order)

This Order amends the definition of "the Stock Exchange" in the Data Protection (Transfer in the Substantial Public Interest) Order, 2002 to change the reference to the "Channel Islands Stock Exchange LGB" to the "Channel Islands Securities Exchange Authority Limited". This reflects the restructuring of the former Channel Islands Stock Exchange LGB into the Channel Islands Securities Exchange Limited and the Channel Islands Securities Exchange Authority Limited the latter of which is carrying out functions of a regulatory nature such as those set out in the 2002 Order.

This Order comes into force on the 20th day of April, 2015.
