

**The Immigration and Asylum Act 1999 (Fees)
(Bailiwick of Guernsey) (Amendment) Order, 2015**

Coming into operation

1st June, 2015

THE HOME DEPARTMENT, in exercise of the powers conferred upon it by section 5 of the Immigration and Asylum Act 1999 as extended to Guernsey by the Immigration and Asylum Act 1999 (Guernsey) Order 2003^a, and by section 166(3) of the Immigration and Asylum Act 1999 as extended to Guernsey by the Immigration (Guernsey) Order 2011^b hereby makes the following Order:-

Amendment of the Fees Order.

1. The table in the Schedule to the Immigration and Asylum Act 1999 (Fees) (Bailiwick of Guernsey) Order, 2011^c is replaced with the following table –

Variation of leave to enter the Bailiwick for a limited period.	£649.00

Interpretation.

2. The Interpretation (Guernsey) Law, 1948^d applies to the interpretation of this Order.

Revocation.

3. The following Orders are revoked –

- (a) the Immigration and Asylum Act 1999 (Fees) (Bailiwick of Guernsey) (Amendment) Order, 2014^e, and
- (b) the Immigration and Asylum Act 1999 (Fees) (Bailiwick of Guernsey) (Amendment No. 2) Order, 2014^f.

Citation.

4. This Order may be cited as the Immigration and Asylum Act 1999 (Fees) (Bailiwick of Guernsey) (Amendment) Order, 2015.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order increases the fees payable under the Immigration and Asylum Act 1999 (Fees) (Bailiwick of Guernsey) Order, 2011 ("**the Fees Order**") in connection with applications for leave to remain in the Bailiwick of Guernsey for an indefinite period, for leave to remain or variation of leave to remain for a limited period or for variation of leave to enter for a limited period. The same fee applies to applicants and dependants of applicants.

Article 1 of this Order replaces the table setting out the relevant fees in the Fees Order.

Article 2 of this Order sets out the interpretation provision.

Article 3 of this Order revokes the Immigration and Asylum Act 1999 (Fees) (Bailiwick of Guernsey) (Amendment) Order, 2014 and the Immigration and Asylum Act 1999 (Fees) (Bailiwick of Guernsey) (Amendment No. 2) Order, 2014. The provisions of those Orders are either spent or superseded by this Order.

Articles 4 and 5 are the citation and commencement provisions respectively.

This Order will come into force on the 1st June, 2015.
